RENTAL SUBSIDY PROGRAM Appropriations as of December 31, 2022

Chicago Low-Income Housing Trust Fund is a city-wide housing resource for the working poor, disabled, seniors and others living at or below 30% of the area median income (\$26,400 for a family of four). Approximately forty-percent of Trust Fund subsidies are directed towards special initiatives; including assistance for individuals and families to enable them to move from shelters and outdoor spaces into permanent housing, persons living with HIV/AIDS, veterans, and female-headed households in employment training programs. ***Please note that numbers are estimated and may not reflect actual numbers and MAUI numbers are included.**
